

# 'LIC likely to move ₹1.8-lakh cr into shareholders fund'

Life Insurance Corp of India (LIC) is planning to transfer nearly ₹1.8-lakh crore from policy holders' funds into a fund earmarked to pay dividends or issue bonus shares, two sources said on Friday, as the country's largest insurer aims to shore up both its own net worth and investor confidence.

### **35% FALL**

The State-owned insurer listed on stock exchanges in May, but its stock has since dropped more than 35 per cent, wiping off nearly ₹2.23lakh crore in investor wealth.

LIC is now looking at steps to revive its share





The transfer, if concluded, would boost LIC's net worth by about 18 times from its current value of about ₹10,500 crore and top the net-worth chart among insurers, including SBI Life and HDFC Life, both the officials said.

LIC and Finance Ministry did not immediately respond to e-mails from Reuters seeking comment.

A bigger shareholder fund would draw the attention of new and existing investors as the amount would be used by LIC to transfer dividend or issue bonus shares in future, said Harvinder Singh, a partner at law firm DSK Legal.

## SEBI cuts face value for debt issues to ₹1 lakh

Markets regulator SEBI on Friday reduced the face value of debt security and non-convertible redeemable preference share issued on private placement basis to ₹1 lakh from the current ₹10 lakh. The move is to enhance liquidity in the corporate bond market, SEBI said.

The regulator said it has received representations from various market participants, including issuers, requesting for review of the denominations.

"In particular, non-institutional investors consider the high ticket size as a deterrent which restricts their ability to access the market for corporate bonds. If the face value and trading lot is reduced, more investors can participate which, in turn, will enhance the liquidity in



the corporate bond market," it said.

The new guidelines will be applicable from January

However, with respect to shelf placement memorandum which is valid as on January 1, 2023, the issuer thereof will have the option while raising funds through tranche placement memorandum to keep the face value at ₹10 lakh or ₹1 lakh, SEBI clarified.

# Global Health sets price band at ₹319-336, issue opens on Nov 3

Global Health Ltd, which operates and manages hospitals under the Medanta brand, said it has set a price band of ₹319-336 a share for its ₹2,206-crore initial public offering (IPO).

The IPO will open for public subscription during November 3-7. The bidding for anchor investors will open on November 2.

The IPO consists of a fresh issue of equity shares aggregating to ₹500 crore and an offer for sale (OFS) of up to 5.08 crore equity shares. As a part



of the OFS, Anant Investments, an affiliate of private equity major Carlyle Group, and Sunil Sachdeva (jointly with Suman Sachdeva) will offload equity shares.

Currently, Anant Invest-

ments holds a 25.64 per cent stake in Global Health and Sachdeva owns a 13.41 per cent stake in the company.

### USE OF FUNDS

At the upper end of the price band, the company is expected to raise ₹2,206 crore. Proceeds from the fresh issue will be used to pay debt and for general corporate purposes.

Half of the issue size has been reserved for qualified institutional investors, 35 per cent for retail investors and the restfor non-institutional investors. Investors can bid for a minimum of 44 shares and in multiples thereof.

# WhatsApp chats: Regulators struggle to fix insider trading cases

Regulators across the globe are finding it difficult to fix insider-trading based on WhatsApp chats.

Recently, according to a Bloomberg report, the US Securities and Exchange Commission (SEC) asked money managers for details on who at their firms oversees retention of electronic communications.

Under SEC rules, money managers face less expans-

However, like banks, investment firms are required to monitor communications involving their business to head off improper conduct, said the Bloomberg report.

### WHATSAPP LEAK

wall. SEBI recently suffered a set-back in a WhatsApp

The Supreme Court reiected SEBI's appeal to penalise a senior employee of a Mumbai equity brokerage house for sharing stockprice sensitive data on WhatsApp on the grounds that the regulator went behind the secondary source of the leaked data and could not find the primary source of the message.

In 2017, SEBI found forecasts by several brokerages that seemed to have knowledge on price-sensitive information such as financial results ahead of official announcements from com-

Following this, SEBI had conducted raids on 26 suspected entities and investigated nearly 190 phones of individuals at brokerages and found that the messages by them were a close approximation of actuals. SEBI suspected this to be an alleged insider trading and cracked the whip on them.

It imposed ₹15 lakh penalty against Neeraj Kumar Agarwal and Shruti Vora, then employees of Antique Stock Broking, for forwarding the messages.



### SETBACK AT SAT

The individuals then moved Appellate Securities (SAT), Tribunal which, while dismissing the regulator order, said: SEBI failed "to prove any preponderance of probabilities that the impugned messages were unpublished pricesensitive information, that the appellants knew that it unpublished pricesensitive information and with the said knowledge they or any of them had passed the said information to other parties".

Accordingly, the tribunal set aside SEBI's orders in the case.

SEBI then escalated the issue with Supreme Court, which also declined to entertain the regulator's arguments, saying: "They are secondary chain. They have just forwarded the messages. It would mean upsetting everything and putting the burden again on them, which we are not willing to do... On the facts and circumstances of the case, we find no reason to entertain the appeal."

Following these verdicts, SEBI also on its own has disposed of similar cases that it was pursuing.

Does this set-back mean SEBI cannot not rely on WhatsApp and other electronic trails that can offer corroborative evidence to fix insider-trading? Though the SEBI approach was clear, it could not conclusively convince the higher judicial authorities with the data that it had collected.

Despite these set-backs, SEBI should actively pursue e-trails and as Supreme Court said, it should go after primary sources of such leaks which can be easily done in this advanced technological era.

For that, it has to strengthen its data analytics team which should work in tandem with other regulatory bodies, concerned authorities and India Inc to nab the culprits.
